DAYCARE/BOARDING/ADVENTURES: CONSENT FORM

Please initial that you have read and understand each point.

1. I am the legal owner, or agent for the owner, of the dog described in the attached application form.

2. I release Four on the Floor k9 Behavioural Center, (Four on the Floor) and its staff, owners, representatives, and agents from any and all liability which I or my dog may suffer including but not limited to injury, sickness, damage or death resulting from participation in daycare, overnight boarding, or outdoor trail walks, bike rides, swimming and/or other outdoor adventures. _____

3. I represent that my dog is in good health, is current on all required vaccinations (DHLPP, Rabies, Bordatella), is free of fleas, ticks, lice and has not been ill with any known contagious viruses in the last 30 days. I understand that while my dog is fully vaccinated that vaccines are not guaranteed and there is a small risk that my dog may contract a contagious disease or illness. I agree that should this occur I am responsible for my own pet's care and medical attention. It is owner's responsibility to report any illness or limitation the dog may have upon arrival for daycare or boarding or for any activities that they prefer that their dog(s) not be included in. _____

4. I understand that although all dogs are fully supervised that incidents of injuries may occur from playing with the other dogs, which include but not limited to bites, scrapes, scratches, and sprains.

5. I represent that my dog is sociable and has not harmed or shown threatening behaviours towards any person or any other dog. I understand Four on the Floor reserves the right to remove my dog from the play area and place my dog in a separate holding area should my dog display any unwanted behaviours. I understand that Four on the Floor reserves the right to permanently remove a dog from its daycare or boarding facilities at anytime. _____

BEHAVIOURAL DOGS

- Dogs that exhibit serious behavioural issues which may be either disruptive or potentially harmful may be required to participate in private sessions while at daycare to address the more serious behaviour issues. Owner will have the ability to consent to sessions or remove the dog from daycare. Owners are responsible to pay for the private session fees. _____ (owners initial)

- If your dog(s) have been deemed to have behavioural issues, his interactions and activities may be limited. Owners are responsible for any injury or damage animal may cause.

FOUR ON THE FLOOR RESERVES THE RIGHT TO REFUSE SERVICE

PAYMENT

- Daycare and boarding fees are due upon drop off
- All accounts that are past 30 days due are considered overdue and may result in late charges
- It is understood that all fees paid for services are non-refundable and payment is rendered at time of services or billed out at the end of each month (at the discretion of Four on the Floor management). Payment must be made even if Owner or Four on the Floor decides to eliminate services regardless of reason(s). Pet owner is responsible for legal costs for any action necessary for enforcement of this agreement or any part of this agreement as well additional charge may be charged for time and expenses of any employee of Four on the Floor relating to the enforcement of this agreement.

6. I allow Four on the Floor staff to contact my veterinarian or any other accessible vet clinic as deemed necessary should any injuries require medical attention. I agree that I am solely responsible for any medical expenses acquired for my dog. _____

*****BOARDING DOGS must provide a credit card number on file incase of emergency. Four on the Floor is not responsible for expenses***** Owners will provide all food and medications, Four on the Floor reserves the right to purchase additional food and/or supplies if needed. Owner agrees to reimburse Four on the Floor for said additional food and/or supplies. _____

7. I agree to disclose any previous or current medical issues or concerns of my dog so that Four on the Floor Staff can make a determination of suitability for daycare or offsite boarding. _____

8. I release Four on the Floor K9 Center from any liability should my dog injure another dog or person and accept medical and legal responsibility for my dog's actions. _____

9. I release Four on the Floor from any liability should death of my dog occur for any reason while in daycare or off-site overnight boarding. _____

10. I agree that my dog may be recorded on camera and its images may be used for Four on the Floor promotional material. _____

11. I agree to pick up my dog prior to closing time. Should I fail to do so I understand I will be charged late fees in the amount of \$15 for every 15 minutes or portion of up to one hour. I understand that dogs left after 8pm will be charged \$50 in addition to the daycare fee to account for the late fee plus boarding

fee whether my dog is boarded or not. I understand that should this occur I may not be able to pick up my dog until the following day as well as be charged additional fees for food and other supplies used for boarding for my dog. If owner would like dogs picked up by Four on the Floor employees, while owner is at work or out of town, it is agreed that Four on the Floor will retain keys and any necessary access codes to Owners property. If the Owner wishes to quit the pickup of their dog any said keys or access codes will be returned in person to the owner. __

12. I understand that boarding services are charged on a 24 hrs basis with drop off and pick up permitted only during hours of daycare operation. Boarding pick up beyond 24hrs from time of drop off will be charge additionally at a corresponding daycare rate or may be subject to an additional boarding night. I understand that Four on the Floor reserves the right to refuse after hours pick up. _____

In the event that you, your emergency contact, or any other person you have authorized to us in writing does not pick up your dog on the agreed upon departure date, you hereby authorize us to continue to provide boarding and any additional services at your expense. If such dog is deemed abandoned under provincial laws Four on the Floor will use its discretion permitted by law to follow the Abandoned Pet Procedure.

ABANDONED DOG PROCEDURE:

Four on the floor will attempt to contact you by telephone and/or in writing using the information you have provided, advising you that if your dog is not picked up within 7 days, your dog will be deemed to be abandon and we will deliver your dog to a third party adoption partner. If you fail to pick-up your dog for any reason, you release Four on the Floor and its staff, owners, representatives and agents from further liability and responsibility for your dog.
